The Americans with Disability Act prohibits disability discrimination. Alaska has additionally implemented the Alaska Human Rights Law. It prohibits employment practices that discriminate on the basis of disability. The Law covers all public and private employers regardless of size, except for nonprofit educational, charitable, and religious associations (AK St. Sec. 18.80.010). A disability is defined as:

- A physical or mental impairment that substantially limits one or more major life activities.
- A history of being misclassified as having such an impairment.
- Having an impairment that does not substantially limit a major life activity but is treated by the person as constituting such a limitation.
- Having an impairment that substantially limits a person's major life activities only as a result of the attitude of others toward the impairment.
- · Having no impairment, but being treated by others as having such an impairment.
- A condition that may require the use of a prosthesis, musculoskeletal, special sense organ, respiratory including speech organs, cardiovascular, reproductive, digestive, genitourinary, hemic and lymphatic, skin, and endocrine.
- A mental or physiological disorder, including intellectual disability, organic brain syndrome, emotional or mental illness, and specific learning disorders.

If you feel you have been discriminated against by an employer, there are resources to assist you. The Disability Law Center of Alaska is an independent non-profit law firm that provides legal advocacy for people with disabilities in Alaska. They are able to help with Social Security applications, disability-related employment discrimination, Medicaid appeals, special education, access to voting, and complaints to DVR, TVD, and Independent Living Centers. You can also file a complaint with the U.S. Equal Employment Opportunity Commission. If you feel you have been discriminated against in any form by an employer and need assistance, contact the Disability Law Center of Alaska and EEOC and see if they can assist you.
